Parties have settled the matter and an amount of INR 39,11,367/- has been agreed to be paid by Bajel Projects Limited as full and final settlement (erstwhile Bajaj Electricals Limited) and accordingly B S Construction has withdrawn the application filed before MSEFC.

There is no impact of such settlement on the financial position of the Company, except for an outgo towards the provision made in the Company's books of accounts.
